- To be valid, this pink form of proxy together with the power of attorney (if any) or other authority (if any) under which it is signed or a notarially certified copy thereof, must 7. be completed, signed and lodged with the Company's share registrar. Computershare Hong Kong Investor Services Limited, at 17M Floor, Hopewell Centre, 183 Queen's Road East, Wanchai, Hong Kong, not less than 48 hours before the time fixed for holding the Court Meeting (or any adjournment thereof). If this **pink** form of proxy is not so lodged, it may alternatively be handed to the Chairman of the Court Meeting before taking of the poll, who shall have absolute discretion as to whether or not to accept it. Completion and return of this **pink** form of proxy will not preclude you from attending and voting at the Court Meeting (or any adjournment thereof) in person if you so wish, but in such event, this **pink** form of proxy will be deemed to have been revoked.
